CORPORATE MEMBERSHIP INFORMATION

- ✓ Lakewood Golf Resort offers a limited number of Corporate Memberships.
- ✓ Each tee time booked is deemed as a starting time. Individual plan determines 9 or 18 holes. A starting time consists of 4 green fees and two Power Carts.
- ✓ Tee times can be used Monday through Friday (excluding holidays) and booked up to 14 days in advance throughout the golf season (subject to availability). The exception to this rule is if you have purchased the platinum plan.
- ✓ A 24 hour cancellation policy is in effect.
- ✓ Unused times cannot be used the following year and cannot be doubled up on the same day throughout the season.
- ✓ Company credit card number must accompany membership application as security for incidental charges throughout the year.
- ✓ Corporate memberships are non refundable and non transferable.
- ✓ Only named players can book a starting time.
- ✓ At least one of the named players must be playing with their group in the starting time.
